Chronic homelessness is life threatening and complex, but it's solvable with the right approach.


Chronic homelessness can be solved, and the Northwest Michigan Coalition has committed to ending chronic homelessness by 2028.


RESOLUTION TO END CHRONIC HOMELESSNESS BY 2028

In December 2024, the City of Traverse City adopted a resolution supporting the Northwest Michigan Coalition to End Homelessness' effort to "end chronic homelessness through permanent supportive housing." The resolution acknowledges the importance of permanent supportive housing and commits the city to actively collaborating with the coalition, leveraging city resources, and promoting awareness around the issue of chronic homelessness.


TOTAL SYSTEM COST: \$6.5M / YR




CHRONIC HOUSED IN 2023




CHRONIC HOUSED IN 2024




CHRONIC INFLOW COMPARISON









FORMULA TO DETERMINE NEED

Based on the data, this formula can help us determine the need for Permanent Supportive Housing units in Grand Traverse County.

- Dedicated PSH Units in System: X
- People Currently Experiencing Chronic Homelessness: X
- Average New Chronic Cases Per Month: X
- Projected New Chronic Cases Over 3 Years: $X \times 36 = X$
- Annual PSH Unit Turnover (10% attrition): X
- Total Turnover Over 3 Years: X
- Total PSH Placement Capacity Over 3 Years: $X/\text{month} \times 36 = X$
(assumes status quo pace includes turnover placements)

**For example, if we had 125 PSH units dedicated to chronic population
AND 70 people experiencing chronic homelessness:**

Category	Estimate
People Currently Chronically Homeless	70
New Chronic Cases (over 3 years)	252
Total People Needing PSH	322
Total PSH Placement Capacity	144
Gap – Additional PSH Units Needed	≈178 units
